## Dear Brother Bland:

This letter is intended to inform you that the Washington State Department of Labor and Industries has put in effect an emergency rule providing the issuance of temporary permits in lieu of certificates of competency for electricians coming from out of state. Under the emergency rule, electricians who have completed an equivalent state regulated four-year journey level electrical apprenticeship program or possess an equivalent journey level electrician certificate obtained by examination in another state, have taken at least 96 hours of classroom training and can meet the requirements under RCW 19.28.181 are eligible for a temporary permit.

Once members are ready to work in Local 191 they must come to the IBEW Local 191 hall to be dispatched off the books on a conditional dispatch. After receiving the conditional dispatch members will complete the temporary permit application with the union's assistance. Members will then bring the completed application to Labor and Industries and once approved will receive a 30-day temporary letter (may take up to three days). Once this 30-day temporary letter is obtained, return to one of the Local 191 halls to receive the actual dispatch. Members will then report to the contractor they have been dispatched to. Labor and Industries will send the 90-day permit to the contractor.

Enclosed you will find detailed information including an eligibility checklist. It is vital that your members complete this eligibility form prior to traveling to Local 191. The temporary electrician permit is only valid for 90 days and is not renewable.
